*Meeting Minutes from February 28, 2013*

- I. **Opening:** 7:30 - *(Delayed due to Pre-Registration Night)*
- II. **Roll Call**
  - a. **Members Present:** *Rocco Warren, Rob Daniels, Chuck Gemma, Vic Blanchard, Jake Richard, Joe Hasselman, Danny Troche, Tyrone Arce, Charlie Arce, Lori Beaudoin, Ryan Pelecchia and Roman Ferguson.*
  - b. **Members Absent:** *None*
- III. **Division Placement Committee**
  - a. *Charlie Arce brought up the Division Placement Committee and recommended that the Committee should be made up entirely of personnel that are not affiliated with the Rules Committee. This was debated for several minutes and the final decision was made that the Committee would be made up solely by personnel who do not play in the league.*
