- I. **Opening:** 6:40
- II. **Roll Call**
 - a. **Members Present:** *Charlie Arce, Lori Beaudoin, Jake Richard, Joe Hasselman, Danny Troche, Ryan Pellechia and Rocco Warren*

 - c. **Members Absent:** *Robbie Daniels and Roman Ferguson*
- III. **Board of Director Interviews**
 - a. *Jon Haxton and Doug Hare interviewed to fill the vacant positions on the Board.*
 - b. *Jon Haxton brings 10 years of playing experience to the league and was approved to join 7-0. Motion to nominate was by Ryan and the motion was seconded by Lori.*
 - c. *Doug Hare has been involved with the league in some capacity as far back as 1978 and was approved to join 7-0. Motion to nominate was by Danny and the motion was seconded by Joe.*
- IV. **Field Use – May 10, 2014**
 - a. *The Eagles are looking to use the fields for a tournament originally scheduled for this upcoming fall, that has been pushed back to May 10th of next year. The board voted unanimously in favor of donating the fields to the Eagles for their event. Motion brought forth by Lori and seconded by Joe.*
